

## COMMUNITY COOKOUT OFFICIAL RULES

---

- 1. Eligibility.** Open only to individuals who are legal residents of the 50 United States and the District of Columbia, 18 years of age or older. Employees of the Organizer and its affiliated companies, subsidiaries and the immediate family members of and any persons domiciled with such employees or agents, are not eligible to win or to claim the prize. All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted.
- 2. Entry.** To enter, submit a photo of your home tailgate to the Community Cookout Event on [www.facebook.com/worldfoodfestival](http://www.facebook.com/worldfoodfestival). Each post counts as one entry. Photos may be submitted until 11:59 p.m. on September 19, 2020.
- 3. Prize.** The prize includes one Tandem Bud Light Bicycle, World Food & Music Festival merchandise (one apron, one set of 100 mini flags, two maracas, two koozies, two stickers and two cups) and \$50 in food and drink tickets for the 2021 World Food & Music Festival. The total value for the prize is \$528.00.
- 4. Notification and Acceptance.** The Organizer will select one entry at random and will announce a winner on Facebook on September 20, 2020 at 3 p.m. The winner must respond to the Organizer by September 25 at 5 p.m. in order to claim the prize. If the winner does not claim the prize by that time, The Organizer will draw another name until the prize is claimed. The individual components of the prize package are subject to availability and Organizer reserves the right to substitute prizes of equal or greater value. Except where prohibited, participation in the drawing constitutes participant's consent to the publication of his or her name, biographical information and likeness in any media for any commercial or promotional purpose, without limitation or further compensation.
- 5. Participation.** By registering, participants agree to be bound by these Official Rules and the decisions of the Organizer. Organizer reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this drawing as solely determined by the Organizer. In the event the drawing is compromised, tampered with, or made impossible due to events beyond the reasonable control of the Organizer which corrupts or impairs the administration, security, fairness or proper operation of the drawing, Organizer reserves the right in its sole discretion to suspend, modify or terminate the drawing. Should the drawing be terminated prior to the stated drawing date, Organizer reserves the right to award prizes based on the entries received before the termination date.
- 6. Limitations of Liability.** By entering the program, participants agree that (1) any and all disputes, claims and causes of action arising out of or in connection with the drawing, or any prizes awarded, shall be resolved at the discretion of Organizer without resort to any formal claims, causes of action or dispute resolution proceedings; (2) any claims shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the drawing, but in no event attorney's fees; and (3) under no circumstances will any participant be permitted to obtain any award for and participant hereby waives all rights to claim punitive, incidental or

consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.

Construction.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any participant and Organizer, shall be governed by and construed in accordance with the laws of the State of Iowa, without giving effect to any choice of law or conflict of law rules or provisions. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. If any such provision is determined to be invalid or otherwise unenforceable, these Official Rules shall be construed in accordance with their terms as if the valid or enforceable provision was not contained therein.

**8. General Release.** By entering this drawing, participants release Organizer and its affiliated companies, directors, officers, employees, representatives, partners and agents from any liability whatsoever for any claims, costs, injuries, losses or damages of any kind arising out of or in connection with any drawing or with the acceptance, possession or use of any prize (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light.)

**9.
